## INDIVIDUAL SUPPORT AND SERVICES MENU

### PERSON CENTERED ASSESSMENT AND PLANNING SERVICES

ONE-ON-ONE DAILY LIVING ASSESSMENT \$27.00/hr

Assessment in the person's home to determine daily living skills and abilities. Time limited assessment to identify outcomes related to improving one's daily living skills.

INCLUSION ASSESSMENT \$27.00/hr

Assessment of the person's participation in a local group or activity to determine relationships and skills related to independent or naturally supported participation. Time limited assessment to identify outcomes related to increasing or improving one's participation in a local group or activity.

SPECIFIED ASSESSMENT TOOL REQUESTED \$27.00/hr

Depending on the request of the individual, staff expertise in these areas is available: Personal Futures Planning and Circles of Support.

SERVICE PLAN DEVELOPMENT \$27.00/hr

Realistic and individualized ISP development based on person centered planning techniques, a team approach to turning visions and dreams into realistic steps toward personal success.

SERVICE PLAN CONSULTATION AND IMPLEMENTATION \$27.00/hr

Simple techniques on how to positively implement a new service plan with individual or family.

PRE & POST SERVICE PLAN FOLLOW ALONG \$27.00/hr

Assist and support during the planning, follow-up and closing phase of person centered planning process. Services may include facilitation at check in, explanation to attendees, coordination of plan's outcomes, follow up meetings for further explanations, and process updates.



**COMMUNITY LIVING SUPPORTS**

FAMILY SUPPORT \$25.00/hr

Training, assisting, and educating the family to increase their ability to support a family member with disabilities at home.

IN HOME LIVING, ONE-ON-ONE SUPPORTS \$18.00/hr

In home assistance with activities of daily living in the person's home. Skills training in areas like grooming, meals prep, cooking, bathing, etc. Promote independence by training the individual to gain or maintain skills to live as independently as possible.

COMMUNITY INCLUSION, ONE-ON-ONE SUPPORTS \$18.00/hr

In a 1:1 framework, facilitate independence, recreation, and skill acquisition and promote community integration by supporting the individual to gain or maintain skills in the community, a local group or activity with relationship building and /or naturally supported participation.

PEER-TO-PEER SOCIALIZATION SUPPORTS \$23.00/hr

In a group framework, provide opportunities for socialization with other individuals. Provide personalized or group learning activities that match the person's outcomes and interests

COMMUNITY INCLUSION, GROUP SUPPORTS \$23.00/hr

In a group framework, provide opportunities to participate and learn with others.

ROOMMATE SERVICES \$35.00/hr

Individualized roommate/companion training geared for the specific needs of the individual, family, or organization wanting to select their own roommate/companion using most recent state and federal labor laws, BOLI approved techniques and proper documentation.

RELIEF ROOMMATE SERVICES see below

Assistance with general household routines by providing a trained relief roommate when regular roommate/caregiver is away. Must include 8 hours of uninterrupted sleep time and private sleeping quarters for the roommate if overnight. If sleep time is interrupted, it will be at \$15.00/hr.
